Documents to be provided (mandatory)

- Scan of **Passport data page**
- Copy of the **last bank statement** showing your capacity for financial autonomy (funds available)
- Copy of **mission letter** from your company confirming that you are their employee, the reason for the trip and that the company will bear all your expenses related to this trip
- Sworn statement from your employer that they comply with UK immigration laws (or insert into mission letter wording such as "... will return into his job at our company after UK visit...")
- Copy of **invitation letter** from the inviting company in UK specifying the nature of your visit, the dates, the scope of your intervention, mentioning you will be returning back to France following this visit, etc.

NB: other documents and questions may be requested/formulated throughout the procedure
